Louis Hebert called the Zachary Taylor Parkway Association Board Meeting to order at 10:56 AM.

Roll call was led by Melvin Harvey.

Mr. Hebert asked the board to review the minutes from January 12, 2022, located in the meeting packet. J.R. Rouchon made a motion to approve the January 12, 2022, minutes. Ron Roe seconded the motion. The motion passed unanimously.

Mr. Harvey reviewed the financial report for 2022 year-to-date. He reported that the total revenue was \$6,533.00 with \$4,743.00 in total expenses leaving an excess of expenses over revenue in the amount of \$1,790.00.

Mr. Hebert gave the membership report update. He encouraged the board to continue to pursue dues collections and to send any prospective members to the management team for outreach and follow-up. He also reported that membership dues renewals for 2023 will go out in December.

Mr. Harvey reviewed the Zachary Taylor Parkway Commission resolution request for support in lighting of the Audubon Bridge which was previously sent to West Feliciana Parish President Kenny Havard and hand delivered to Pointe Coupee Parish President Major Thibaut by Louis Hebert. Mr. Harvey requested assistance from State Representative Roy Adams in securing funding for this initiative. Representative Adams



recommended that the Association's initial request should be \$1.3 million to start the process of lighting the bridge. J.R. Rouchon made a motion that the Zachary Taylor Parkway Association request \$1.3 million in Capital Outlay funding to light the Audubon Bridge. Ron Roe seconded the motion. The motion passed unanimously.

Mr. Hebert announced the next board meeting will be held in West Feliciana Parish on January 11, 2023.

Wilbert Carmouche motioned to adjourn the meeting. A.P. Guillory seconded the motion. Mr. Hebert adjourned the meeting at 11:09 A.M.
