Louis Hebert called the Zachary Taylor Parkway Association Board Meeting to order at 10:45 AM.

Roll call was led by Maggie Miller. A quorum was not recognized.

Mr. Hebert reviewed the financial report as of March 31, 2022. He reported that the total revenue was \$6,333.00 with \$21.00 in total expenses leaving an excess of expenses over revenue in the amount of \$6,312.00. Mr. Hebert made a motion to approve the finances. A.P. Guillory seconded the motion. This motion will be ratified at the next meeting when a quorum is recognized.

Mr. Hebert referred to the bylaws in the meeting packet. He asked the board for their thoughts on the potential changes noted on the draft in the packet. After some discussion, Mr. Hebert entertained a motion to adopt the proposed changes to the bylaws at the next meeting in July. J.R. Rouchon made a motion to approve the bylaws changes. Gen. Ron McGlothlin seconded the motion. This motion will be ratified at the next meeting when a quorum is recognized.

Mr. Hebert gave the membership report update. He reported the total dues revenue collected as of April 12, 2022, was \$6,358.00. He encouraged the board to continue to pursue dues collections and to send any prospective members to the management team for outreach and follow-up.



Mr. Hebert announced that the next board meeting will be held July 13, 2022, in Washington Parish.
